NBASLPA Award Nomination Tips

- . Start early!
- Pretend that the judges know nothing about the nominee. We can't score based on what we know about someone anyway!
- . Read the criteria in the intent section of the award descriptions. Contact committee chairs if you have any questions or if you need more information.
 - . Use the criteria as a guide because this is what scores will be based on! Be sure to include specific examples that relate to the criteria.
- Ask the nominee if he/she has a portfolio of newspaper clippings, articles featuring his/her work, research, projects, etc. that you could photocopy to include in the nomination. Ask to see his/her CV or resume for information you could use in the nomination.
- . Ask colleagues, parents, supervisors, etc. to submit a letter or email of support. You can share helpful information with the writers too.
- . Review the nomination yourself or have someone else look it over before you send it in.

If your nominee is not chosen this year, **TRY AGAIN NEXT YEAR!**

Getting to Know Who?

Where are you from?

I am from the west side (the best side) of Saint John, NB. Both the hospital I was born in and the house I grew up in are demolished now. Kind of makes me feel old:-), or maybe they could not survive without me.

Where did you go to undergrad/grad school?

I completed my undergrad at St. Thomas University. Many years later, my family and I moved to Halifax where I completed the Audiology program. This was truly the most fearful event I have ever entered but was a rewarding accomplishment. By no means was this an independent adventure.

Where did/do you work?

I was employed by what is now called Horizon Health Network at the Upper River Valley Hospital in Waterville, N.B., just outside of Hartland from 2008-2012. Since 2012, I have been self-employed as a co-owner of Ritcey Hearing in Woodstock, N.B. with a clinic in Grand Falls as well.

What population?

I have always seen all age groups, but since going private, I rarely see paediatrics now.

What are your top 3 therapy tools?

I always do as much objective testing as possible. So I regularly perform OAE and acoustic reflexes along with audiometer testing. For amplification, I like using perceived needs and wants with lifestyle questionnaires.

Fondest memory as a clinician to date?

I have 2, both are very similar. Both have tinnitus, both are young, both wanted a cure and both had been seeking help before seeing me. I told both the truth that I can not, and will not, cure their tinnitus but I would help with management strategies. One left very informed and went on to write my boss a letter explaining my blunt honesty's helpfulness. Apparently, the truth and hope I gave him was what he needed. The other person was so overwhelmed by my direct truth that she cried with happiness and gave me a huge hug. I provided her direction and ownership of her tinnitus. Helping people gain control over what they perceive as having no control over, inspires me.

If you won the lottery, what's the first thing you'd do?

Get rid of my debts and build a house that is functional for my wife's abilities.

If you could learn to do anything, what would you do?

I would like to be able to equalize my middle ear space under water. Seems simple but I cannot scuba dive. I have tried 2 times which is too bad because I love underwater life and swimming.

Anything inspiring to share with members?

Forget, yes, forget; that is how I live and forgive.

Choose one other NBASLPA member. What is your favourite thing about that person?

My wife fully and absolutely for everything including her natural personality to have no prejudice toward anyone. However, when I think of where I am today, I often think of 5 others, not just 1.
